Tax Credit & Utility Rebate Update

There are some great incentives available for upgrading your heating and cooling system, and your water heater with energy saving models. The incentives are both in the form of federal tax credits and with utility rebates. For the majority of clients that we serve, the rebates are from SEMCO Energy Gas company or from DTE Energy for electric only customers. (DTE Gas and Consumers Energy customers also

have similar programs that are not listed here.)

The chart on page 2 highlights some of the top incentives available but is only intended as a starting point.

The Federal Tax Credits are for 2019 and renewed for 2020. If you made an investment last year that qualifies, be certain to take advantage of the credit. Alternatively, consider taking advantage of these this year. Your actual tax credit may be

limited by a total combined credit limit of \$500 for all tax years after 2005.

Federal Tax Credit \$150 for furnace or boiler with an AFUE rating of 95% or higher. \$50 additional credit for "Furnaces with Advanced Main Air Circulating Fan". This would include 'ECM' or 'Variable' blower motors such as Amana model numbers containing either a 'V' or 'E'.

Note: some 80% AFUE

models might qualify for this tax credit.

2020 SEMCO Energy Gas Rebate: Furnace: \$250 AFUE 94%+ / \$350 AFUE 96%+ / \$450 AFUE 98%+. Boiler: \$800 AFUE of 90%+. Boilers that we install that qualify are the wall hung Viessmann or Navien models. Cast Iron boilers such as the Weil McLain models do not provide the efficiency levels to qualify for a rebate or a tax credit.

Water Heaters

To qualify for a **Federal Tax Credit** a water heater must either be a model that has an electric heat pump or a Uniform Energy Factor (UEF) of .82 or a thermal efficiency of 90%+. Typically, this is a tankless water heater.

2020 SEMCO Energy Gas Rebate: A tankless natural gas water heater (with .81+ UEF rating) (with or without a boiler) qualifies for an additional **\$275** rebate. Very few tank type water heater models meet the minimum .64 UEF efficiency rating to qualify for the **\$100** water heater (tank) rebate.

Air Conditioners

It is hard to qualify for an air conditioner rebate or tax credit. This is because it has to be rated as an entire matched system, consisting of the condenser (the outside part), the evaporator coil (the part that attaches to the furnace) and the furnace or air handler that it is connected to. The equipment manufacturer has all three of these components tested as a

matched system by AHRI (Air-Conditioning, Heating & Refrigeration Institute) to determine the efficiency rating. **Here are things to consider in order to qualify:**

- 1) Don't mix equipment brands.
Amana does not pay AHRI to rate its Amana air conditioners with Carrier furnaces – it rates them with Amana furnaces, and so on. AHRI does not have rating numbers for unmatched brands.
- 2) Replace the furnace and the air conditioner together.
Manufacturers do not rate new air conditioners with old furnaces. AHRI will probably not have a rating for a new air conditioner with an older furnace model. It is a good practice to replace the entire system at one time – just like replacing all four tires on a car together rather than one or two at a time.
- 3) The furnace needs to have a high efficiency 'ECM' or

'Variable' blower motor (as discussed above in the *Furnace & Boiler* section) in order to qualify for the AC tax credit.

- 4) The last consideration is the evaporator coil. In some situations, the coil needed to achieve the desired efficiency may be too tall to fit in the space available – that is, there is not enough height between the top of the furnace and the ceiling to install a qualifying coil.

In this instance a shorter coil may be all that will fit, but will disqualify the system from achieving the desired AHRI matched system efficiency rating. In the bigger scheme of things, typically it is more cost effective to forego the tax credit or utility rebate, than to perform any costly duct or system modifications needed to make the coil fit.

When you look at a review, you should keep this in mind. But there is one way for you to have a high level of confidence when you look at a review to know that you can rely on it: a high quantity of reviews and a matching high score. This is because the more reviews there are, the less impact that 'games' or 'tricks' can be a factor.
